LOOK AFTER YOUR PLOT!

USE IT OR LOSE IT - THE RULES ON NEGLECTED PLOTS ARE BEING TIGHTENED

As ploholders yourself, you know how long you had to wait for the privilege of having an allotment in Hackney. Allotment land in inner city areas is a scarce resource, and we are lucky in Hackney to have provision of 125 plots on 9 sites around the Borough, yet we still can't fulfil the demand for plots. Due to this, the waiting list has now been closed for some years.

As most members will know, the Society operates a neglected plot policy. Whilst in general this works reasonably well, there have been some instances of 'repeat offenders', whereby a ploholder improves the state of a plot following receipt of a neglected plot letter, but only in the short term - ie the improved state is not maintained. Under current rules, the Committee is obliged to repeat the entire (lengthy - at least 8 weeks from start to finish) process before the offender leaves and a plot can be handed on to a waiting list member.

The Committee is in discussion about how we can tighten up the rules to help tackle this problem. Allotments must be kept clean and maintained in a good state of cultivation. Paths on allotment sites should be kept clear for access. It simply isn't fair that members without plots are obliged to wait even longer because those ploholders who don't maintain their plots refuse to give them up.

Hackney Council would like to invite you to take part in the Hackney Biodiversity Action Plan Consultation that will be open until 24 October 2011.

Biodiversity is the range of wildlife around us and their habitats. This includes plants and animals. In an urban area such as Hackney, biodiversity also plays a vital role in cleaning our air, reducing the effect of the 'urban heat island' and helping to reduce flooding.

The Biodiversity Action Plan (BAP) is about protecting and encouraging wildlife all across Hackney and also looks at how the built environment can be made more wildlife friendly.
